**Real Estate Conveyances**

Item
Deed Documentary Stamps: Rate .70 cents per \$100 of consideration or fraction thereof on deed or other instrument conveying an interest in Real Estate. A minimum of .70 cents doc stamps must be affixed to deeds which have a consideration of \$100 or less.
Mortgage Documentary Stamps: Rate .35 cents per \$100 or fraction thereof on promise to pay.
Intangible Tax: A nonrecurring tax of 2 mills (2%) on the dollar of the just valuation of all notes, bonds, and other obligations for payment of money, which are secured by mortgage, deed of trust, or other lien upon Real Property situated in the state.
